## A FEW WORDS FROM THE

# **Executive Director**



As we continue to look back on the last 18 months and the changes we have all had to make. lockdown after lockdown and ongoing changes such as wearing masks,

or having to stay within Queensland and away from family and friends in other states, and just simply not knowing what is going to happen tomorrow or the day after, I do reflect on how a child or young person must feel when their lives are so disrupted by change. especially for children who cannot live with their direct families.

Added to their already heightened state of anxiety and the trauma they carry we have Covid. I am always in awe of the power of our children to overcome adversity and new ways of being able to not only cope, but succeed. I don't know how they feel, but I do know that after all these years. I have been privileged to witness so many children and young succeed, grow and mature into young adults free from harm. While writing this article I am watching some of the Olympics and if medals were handed out for succeeding in overcoming adversity our children would get gold every time.

There are many areas of focus for QFKC and everything we do every day is a priority, not only for us, but also for the 5700 Foster and Kinship Carer families we represent, advise, support and advocate on behalf of. When faced with our own adversity and challenges, I have to make some decisions that do not sit easy with me however, I do so knowing that the direct support of our families must come first.

In the past 2 months we have scaled back the facilitation of our training due to the pressure on our Queensland Foster & Kinship Care Case Officers. Training takes considerable time to prepare for, as well as the facilitation, and could mean we have staff away overnight, at times at considerable expense.

Training and professional development of staff is important to us, as this creates an environment where we provide on the ground practical training that helps staff to then support both Foster and Kinship Carers. Hopefully, in the very near future we can resume training, however, that would depend on the availability of time.

In late July I had the opportunity of visiting Wondai in the South Burnett where I facilitated training for the local Foster and Kinship Care support service, Partners in Foster Care. Over the last few years QFKC have been very focused on the need for specialist separate support for both Foster and Kinship Carers and it was so pleasing to see this service, which is only small compared to many, ensuring that their Foster and Kinship Carers have dedicated specialist staff providing that individual support required. For a very long time, the system which includes Foster and Kinship Care services have seen all carers the same and it's not okay. Kinship Carers require a different focus on support and their needs are quite different at times. Foster and Kinship Care services throughout Queensland need to have dedicated workers for the different cohorts of carers. If a relatively small program can ensure their workforce is separated to meet the different carer needs, then there is no excuse for all Foster and Kinship Care programs to follow this example.

QFKC will continue to advocate for best practice for children and young people every day as well as strongly encouraging positive change wherever we can for Family Based Care.

We need more foster carers, like you.

These words could not be more true.

Queensland's army of foster and kinship carers play a critical role in our child safety system and we are always in need of more people, just like you, to open their hearts and homes to children in need.

These words are also the theme of our current foster and kinship carer campaign, which we launched recently. It features carers, like yourselves, sharing their stories and hopefully inspiring more Queenslanders to become carers.

Sadly, last month's Queensland Foster and Kinship Carer Conference had to be postponed at the last minute due to Covid-19 complications. I, like everyone I'm sure, was so looking forward to this event following last year's cancellation, but we will just have to wait a little longer.

My thanks to everyone who worked so hard behind the scenes to bring this event to life in these trying circumstances. Your work does not go unnoticed and I'm sure we will all get to enjoy this wonderful conference together again very soon.

Supporting carers on their journey through practical avenues is a key focus for my department.

One of these relates to fire safety. I would like to remind foster and kinship carers that time is running out to register for free smoke alarms, supplied and installed by the Queensland Government. To be eligible, you must be an approved foster or kinship carer providing full-time or respite care, and the owner occupier of the property being used to provide care.

More than 850 carer households have already had smoke alarms fitted, with almost 80 more homes approved and awaiting installation. This is great news and I hope more carer families take up the offer to help make Queensland households more fire safe.

To ensure your household can benefit, applications must be received by 30 September 2021. To make an application you can visit:

Please note that carers who rent are not eligible as it is the responsibility of the building owner to meet fire safety requirements.

I have to say that one of the best parts of my job is meeting foster and kinship carers from around the state, which I have been able to on some recent travels to the regions, including Cairns, Longreach, Banyo, Townsville, Mackay and in Brisbane.

I am always humbled by the care and consideration given to our children and young people by carers, and I recognise the hard work and resilience you all possess in order to do this job.

Sadly, there continues to be an increasing demand for Queensland's child protection services, and a growing complexity of matters coming to the attention of the system.

The impact of the COVID-19 pandemic has resulted in an increase in the need for foster carers, and I am pleased to say that Queenslanders have been answering this call.

We have seen a 7.7 per cent increase in the number of families stepping up to care for the first time, with 1,655 new families registered in the 12 months to December 2020. In total there were 5,792 carer families as at 31 December 2020, up from 5,512 as at the end of 2019.

I hope to see more Queenslanders registering because we need more foster carers, like you.

Thank you for all that you do to help keep our children safe every day.

# **Service Support Manager Update**

I am writing this edition of the Reporter whilst in lockdown again ... The level of anxiety the world has contended with 18 months on from the first COVID19 case seems to be never-ending. There is a lot of research that points to increased mental health concerns in the wider population that has resulted from the stress, fear and worry arising from the uncertainty of COVID19. During these times it is essential that carers reach out to all their networks for support. Not only do you have the stress the rest of the population carries in this space, there are also the additional layers of stress that come with parenting children in a statutory system during a worldwide pandemic. Remember, if you are reaching out for support through your professional support services and do not feel these needs are being met, contact your FAST Rep or a Case Officer here at QFKC for support.

QFKC are participating on two important working parties, one being the Standard of Care Steering Group which is reviewing all current procedures as they relate to how Standard of Care Reviews continue to monitor and Harm Reports are managed. Last year, QFKC supported Child Safety in the development and distribution of two key surveys that gathered information from key partners in this space, including carers and foster and kinship care agency staff. These results, along with samples of cases that have been undertaken in practice, are being used to assist in the development of procedures that will result in practice that supports all care team members' responsibilities in meeting the Statement of Standards for children and young people in care. We look forward to the completion of this piece of work, which we have no doubt will have a positive impact on the carer households.

The other piece of work that QFKC is involved in, is the redevelopment of the mandatory pre-service Quality Care Training that takes place prior to a Foster Carer being approved. This training is very outdated and does not currently reflect the significant changes to the Child Protection Act that were introduced in 2018.

The current training also lacks messaging around Care Team responsibility and trauma informed care. The current aim for Child Safety is to prioritise the completion of the four modules with up to date information and then continue to add to the content with information that will enrich the training content. The overall goal of course is to have much better understanding of the system.

QFKC as a peak body is in a unique position, because, when we have input into projects such as the above, we do so from not only a systems perspective, but also from a direct service delivery perspective. Our QFKC Case Officers, together with our FAST Reps support in excess of 150 carers every month, these carers have multiple cases attached to them and our tracking of these cases enables us as a Peak to provide a state-wide perspective on the types of issues affecting carers.

QFKC currently has 25 FAST Representatives across our State, FAST Reps have walked in your shoes and understand the frustration of parenting in a statutory system and they understand the highs and lows of being a carer. During these uncertain times in particular, don't wait for issues to become unbearable, reach out for support early on, sometimes a good vent makes all the difference. #### **Regional Updates**

#### Far Northern Area

- The FNQ regions Foster and Kinship Care agencies in partnership with QFKC will be hosting the Triple R Training for Carers on Thursday, 26th August 2021. The Triple R training covers the 'Rights, Roles and Responsibilities' of the caring role. The training looks at key pieces of legislation and documents that speak to these important factors and more importantly, what they mean for carers in providing day to day care for children and young people. All carers are welcome to attend, so please speak with your agency Support Worker NOW if you are interested in attending.
- Did you know that as an approved carer you can access information and support through the Foster and Kinship Carer support line on 1300 729 309, Monday to Friday 5:00pm—11:30pm and Saturday and Sunday 7:00am—11:30pm. This service is provided by the Child Safety after hour's team, and is in addition to the afterhours support provided by your local Foster and Kinship Care Service.
- Later this year the Department will be implementing a new IT system to manage placement referrals. The new system will provide greater functionality for the Placement Services Unit to communicate with the Foster and Kinship Care support agencies, and in Far North Queensland region is expected to go live in October. In preparation for go-live, carers are encouraged to ensure your Foster Care Agreement and Placement Preferences are up to date. If you need to make amendments to your placement preferences, we encourage you to speak with your support agency so a revised Foster Care Agreement can be completed.

#### Northern Area

- QFKC conference has been postponed however, we hope to be able to meet representatives there from the NQ region, and that carers will have the opportunity to have a chat soon.
- Northern Queensland region has been busy planning for NAIDOC week activities, hope all carers were able to celebrate in their area.

#### Smoke Alarm Installation – Applications required by 30 September.



With this year moving quickly we wanted to provide a reminder to all carers to ensure they have considered their need to access smoke alarms for your home through the Smoke Alarm Initiative by 30 September 2021. Applications need to be made by 30 September 2021 to allow works to be completed by 31 December 2021.

The Smoke Alarm Initiative began in January 2018 in response to new legislation that is requiring all homes to have interconnected photoelectric smoke alarms installed in every bedroom, in connecting hallways and on each storey. Together with Public Works, Child

Safety will supply and install smoke alarms free of charge in eligible homes for Queensland's foster and kinship carers.

# NEW LAWS AFFECTING FOSTER AND KINSHIP CARERS



## **Child Sexual Abuse**

On 5<sup>th</sup> July 2021 new laws were introduced which compels all adults to report sexual offending against children to the police unless they have a reasonable excuse, and for adults in institutional settings (this includes the homes of foster and kinship carers) must protect children from the risk of a sexual offence being committed against them.

#### So what does this mean for Carers:

- If a child in your care discloses sexual abuse you must report this, if you report this to Child Safety, you must ensure that Child Safety report this to the Police. A reasonable excuse for not reporting to the police would be, that you have reported the sexual abuse to Child Safety and have been told this information will be shared with the police.
- If you reasonably suspect that a child is being or is at risk of being sexually abused in your home, you must protect the child from the risk of a sexual offence being committed against them. For example, if there is an adult household member or spouse you believe is a risk to the child, you must report this and remove this risk. If you do not, you will be committing an offence.

The following has been taken directly from the Queensland Government's website and provides further context.

For these laws, *child* means a person under 16 or, a person under 18 with an impairment of the mind.

An *impairment of the mind*, as defined in the Criminal Code, means a disability due to an intellectual, psychiatric, cognitive or neurological impairment (or a combination of these), which leaves the person with both:

- a substantial reduction in their capacity for communication, social interaction or learning;
- a need for support.

#### Child sexual offence

A child sexual offence is an offence of a sexual nature committed against a child and includes:

- Indecent treatment of a child
- Carnal knowledge with or of a child;
- Rape;
- Incest:
- Grooming a child (or their parent or carer);
- Making child exploitation material;
- Maintaining a sexual relationship with a child.

Indecent treatment of a child covers a range of conduct of a sexual nature. Examples may include:

- fondling a child in a sexual manner;
- having the child touch a sexual body part:
- taking a sexual photograph of a child.

Grooming a child (or their parent or carer) refers to the way some offenders form relationships and build trust with children, parents, carers, teachers and other children in order to get close to a child and create the opportunity for sexual abuse. It can be difficult to identify because the behaviour itself may not be abusive or sexual. Grooming can often occur online.





# **NEW LAWS AFFECTING FOSTER AND KINSHIP CARERS**

Children need the adults around them to take action to protect them from sexual abuse. These offences target behaviour that ignores or hides the sexual abuse of children.

#### Failure to report

The Royal Commission into Institutional Responses to Child Sexual Abuse (Royal Commission) found that failing to report child sexual abuse to appropriate authorities allowed it to continue and prevented children from accessing the support they needed.

The Queensland Police Service and the Department of Children, Youth Justice and Multicultural Affairs (Child Safety) act on reports of sexual offending against children. They are committed to making the community safer for children and ensuring that children and young people are safe from harm.

To do this vital work, these services need adults to report sexual offending against children.

In a number of their case studies, the Royal Commission heard of circumstances where abuse was not reported to police or where steps were not taken to protect children. Reporting a belief that sexual abuse against a child has occurred or is occurring allows police to investigate and respond to child sexual offences.

The laws mean all adults in the community have a legal duty to report sexual offending against children to the police, unless they have a reasonable excuse for not doing so. Learn more about the failure to protect.

#### Failure to protect

The laws also impose a legal duty on certain adults to protect children from sexual offending. Adults in responsible positions in institutions will have an obligation to protect children in their care from known significant risks of sexual abuse.

If you know there is a significant risk that another adult associated with an institution will sexually abuse a child, it is not enough to wait until sexual offending occurs to inform the police. This legal duty to protect focusses on preventing sexual abuse of children.

The intention behind this law is to ensure individuals in institutions take proactive action to reduce or remove known risks to children. The law attaches a criminal penalty to willful or negligent failures to do so. Learn more about the failure to protect offence.

## **Privilege**

Despite the express provisions relating to religious confessions, the offences are not intended to override privilege, including legal professional privilege and sexual assault counselling privilege.

#### 1. Sortli, a mobile app to help with transition.

Sortli (short for 'sort out your life') is a free mobile app for young people transitioning to adulthood, to help them think about their future life and plan for their transition to independence. It's a fun, informative and easy-to-navigate app that can be installed on a mobile device, so that it can be accessed anywhere at any time. Download for Apple or Android.

Sortli has been developed by young people who have already left the care system and are living independently, as well as professionals who work with young people in care. Sortli is a pocket companion to services and support. It provides a step-by-step guide for all the important areas of a young person's life, such as finding a place to live, looking after health needs, managing a budget, finding a job, or doing some training and general life skills.

It works by helping young people to set their own personal goals and milestones, keep track of their progress and celebrate their successes. The information they enter into the app is stored on their mobile device only and is not provided back to the developers, the government or anyone else. Sortli covers sensitive topics and is not suitable for young people under 15 years of age.

#### 2. About the Carer discount card for Foster & Kinship Carers?

The Carer Business Discount Card scheme recognises the valuable contributions of carers throughout Queensland. The card entitles eligible carers to a wide range of discounts on goods and services from participating businesses across the state.

All approved foster and kinship carers in Queensland are eligible for the Carer Business Discount Card. Your card remains valid for 4 years while you are an approved foster or kinship carer. Only the person named on the card can use it. You will automatically receive the card within 20 business days of being approved and you will continue to receive replacement cards for as long as you are a foster or kinship carer.

If you have been a foster or kinship carer for 2 months or more and have not yet received a Carer Business Discount Card, please contact Card Services, Smart Service Queensland on 13 QGOV (13 74 68). Smart Service Queensland may contact your child safety service centre to make sure your records are all up to date.

#### 3. What changes do I immediately need to inform Child Safety about?

- there is a change in your criminal or traffic history, including if you have been charged with an offence
- you become aware of, or reasonably suspect, there has been a change in the criminal or traffic history of a member of a member of your household
- there is a change related to you, or a household member, being the aggrieved or respondent in a domestic and family violence matter
- if you become aware of, or reasonably suspect, a household member has been involved with Child Safety or a similar child protection agency in another state or country
- when another person intends to join your household—this includes commencing a new relationship with a partner, or if the change relates to a tenant or boarder, a friend or relative
- when another person leaves your household—for example, as a result of separation or divorce, or a household member dies
- you have an intention to provide care to other children in your home, for example as a family day care educator or through the provision of informal care of children
- a change in personal circumstances, for example, significant health problems or excessive employment demands
- a change of address.

#### 4. How to tell Child Safety about any change in your circumstances?

The law requires that you tell Child Safety in writing. You can do this by completing a Change in carer circumstances - Form 39 CCC (cyjma.qld.gov.au) and provide it to your child safety service centre. You can also obtain a copy from either your foster and kinship care service or your child safety service centre.



# Support for grandparents and non-parent carers of children

Grandparent Advisers provide extra support for non-parent carers, including grandparents, foster carers and kinship carers who have taken on parental responsibilities for children.

They can help you by:

- providing tailored information about payments and support services based on your family circumstances
- arranging appointments for grandparent carers and non-parent carers with specialist staff, including social workers
- arranging referrals to federal, state and community service providers, and
- helping with any other Medicare, Centrelink or Child Support enquiries.

# Payments and services

If you're a grandparent or non-parent carer of children and live in the same house as a parent, you may not be eligible for payments. If you're in this situation, you can contact us to discuss your circumstances.

If you're a grandparent or non-parent carer of children, you may be eligible for:

- Family Tax Benefit to help with the cost of raising children
- Child Care Subsidy and Additional Child Care Subsidy (Grandparent) — to help with the cost of child care
- Medicare payments to help with health care costs
- Double Orphan Pension to help with the costs of caring for children who are orphans or who can't be cared for by their parents

- concession and health care cards, including
   Foster Child Health Care Card to help with accessing
   cheaper health care services and medicines, and
- child support you may be able to receive child support from one or both parents.

You may be eligible for other payments and services. Contact us to discuss your circumstances.

We have specialist staff available to provide additional support to your family, including:

- · social workers
- · Financial Information Service Officers
- · Indigenous Specialist Officers
- Multicultural Service Officers
- · Community Engagement Officers.
